Annual Report BUILDING AN EFFECTIVE CITIZENRY

N AREAS of the world where as few as three per cent of the population have a share in planning for their own future through participation in the processes of government, there can be little hope for long range political stability and social and economic progress without major change. Whether change will be peaceful and evolutionary or violent and revolutionary may well depend on the quality and satisfaction of citizen participation.

For twenty years, the Overseas Education Fund of the League of Women Voters has had as its mission the sharing of concepts and techniques of self-help and self-government with citizens in other countries who are seeking to make progress. While the Fund's headquarters services are available to women leaders from all parts of the world, its field activities and intensive training programs have been primarily devoted since 1961 to the women of Latin America.

Our sister nations to the south — brought closer to us every day by rapid improvements in communication and transportation — still lack a necessary dimension for achieving forward progress. Poverty, ignorance, and disease — these problems must be faced and fought with strategies of self-help. And self-help involves self-government and orderly methods of change.

Unlike its parent organization, the League of Women Voters, the Fund does not identify itself with specific governmental issues. Its programs are devoted to helping citizens prepare themselves for participation in resolving social and economic problems as they see fit. Primarily, this means imparting the methods by which groups of citizens learn to analyze the needs of their communities and countries and organize themselves to plan a solution and work toward it.

The learning process must begin with an awakening of the individual's interest in his own potential and his self-confidence in his ability to play an effective part in the governmental process or the voluntary organization. Important — indeed, critical — by-products of the process will be a growing concern for the needs of *all* individuals and increased understanding of the importance of effective human relations. And the visible end result will be stable, orderly progress in the social, economic, and political structures and activities which are the foundations of any society.
